

3 TYPES OF MODELS IN SCIENCE

MODELS IN SCIENCE ARE ESSENTIAL TOOLS THAT HELP RESEARCHERS UNDERSTAND COMPLEX SYSTEMS, MAKE PREDICTIONS, AND COMMUNICATE THEIR FINDINGS. - SOCIAL SYSTEMS: IN SOCIOLOGY, RESEARCHERS MAY USE CONCEPTUAL MODELS TO REPRESENT SOCIAL STRUCTURES AND RELATIONSHIPS. FOR INSTANCE, A MODEL DEPICTING THE SOCIAL HIERARCHY IN A COMMUNITY CAN HELP ANALYZE POWER DYNAMICS AND RESOURCE DISTRIBUTION.

1.3 ADVANTAGES AND DISADVANTAGES

ADVANTAGES:
