2. LEGAL LIMITS

- PUBLIC OPINION: THE GOVERNMENT IS SENSITIVE TO PUBLIC SENTIMENT. CITIZEN ENGAGEMENT IN PROTESTS, PETITIONS, AND OTHER FORMS OF ADVOCACY CAN INFLUENCE POLICY DECISIONS AND LIMIT GOVERNMENT ACTIONS THAT ARE UNPOPULAR OR DEEMED UNJUST.

4. ECONOMIC LIMITS

ECONOMIC FACTORS ALSO IMPOSE LIMITS ON GOVERNMENT ACTIONS. THE GOVERNMENT MUST BALANCE ITS BUDGET, MANAGE RESOURCES EFFECTIVELY, AND RESPECT THE ECONOMIC RIGHTS OF INDIVIDUALS AND BUSINESSES.

COMPONENTS OF ECONOMIC LIMITS

- TAXATION: GOVERNMENTS RELY ON TAXES TO FUND SERVICES, BUT EXCESSIVE TAXATION CAN LEAD TO PUBLIC DISCONTENT. CITIZENS CAN CHALLENGE TAX POLICIES THROUGH ADVOCACY AND VOTING, THEREBY LIMITING GOVERNMENT POWER OVER FINANCIAL MATTERS.

- PROPERTY RIGHTS: ECONOMIC LIMITS ARE ALSO ESTABLISHED THROUGH THE PROTECTION OF PRIVATE PROPERTY RIGHTS. GOVERNMENTS CANNOT ARBITRARILY SEIZE PROPERTY WITHOUT DUE PROCESS AND FAIR COMPENSATION, AS OUTLINED IN THE CONSTITUTION.

5. SOCIAL AND CULTURAL LIMITS

- CULTURAL NORMS: SOCIETAL VALUES AND NORMS SHAPE PERCEPTIONS OF GOVERNMENT LEGITIMACY AND AUTHORITY. IF

CITIZENS BELIEVE THAT THE GOVERNMENT IS ACTING CONTRARY TO THEIR VALUES, THEY ARE LIKELY TO RESIST AND PUSH FOR CHANGE.
