4. UNIQUE PERSPECTIVES: SHARING EXPERIENCES THAT HAVE SHAPED YOUR WORLDVIEW AND APPROACH TO LAW.

## COMMON THEMES IN SUCCESSFUL ESSAYS

THROUGH ANALYSIS OF 55 SUCCESSFUL HARVARD LAW ESSAYS, SEVERAL COMMON THEMES EMERGE THAT ILLUSTRATE WHAT RESONATES WITH ADMISSIONS COMMITTEES.

### 1. PERSONAL NARRATIVES

### 3. INTELLECTUAL EXPLORATION

ESSAYS THAT DEMONSTRATE A DEEP INTELLECTUAL CURIOSITY ABOUT THE LAW TEND TO STAND OUT. SUCCESSFUL APPLICANTS OFTEN DISCUSS:

- RESEARCH PROJECTS OR ACADEMIC PURSUITS RELATED TO LEGAL STUDIES.
- BOOKS, ARTICLES, OR LEGAL CASES THAT HAVE PROFOUNDLY INFLUENCED THEIR THINKING.
- COURSES OR PROFESSORS THAT IGNITED THEIR PASSION FOR LAW.

## 4. PROFESSIONAL EXPERIENCE

MANY APPLICANTS HIGHLIGHT RELEVANT PROFESSIONAL EXPERIENCES THAT ILLUSTRATE THEIR COMMITMENT TO THE LEGAL FIELD. THIS CAN INCLUDE:

- INTERNSHIPS AT LAW FIRMS, GOVERNMENT AGENCIES, OR LEGAL CLINICS.
- ROLES IN STUDENT GOVERNMENT OR LEGAL ORGANIZATIONS.
- EXPERIENCES THAT DEMONSTRATE LEADERSHIP AND INITIATIVE.

## EFFECTIVE STRATEGIES FOR CRAFTING YOUR ESSAY

WHEN WRITING YOUR HARVARD LAW ESSAY, CONSIDER THE FOLLOWING STRATEGIES TO ENHANCE YOUR NARRATIVE:

### 1. START WITH A STRONG HOOK

YOUR OPENING SENTENCE SHOULD GRAB THE READER'S ATTENTION. CONSIDER USING:

- A THOUGHT-PROVOKING QUOTE.
- A VIVID DESCRIPTION OF A PIVOTAL MOMENT IN YOUR LIFE.
- AN INTRIGUING QUESTION THAT SETS THE STAGE FOR YOUR NARRATIVE.

### 2. BE AUTHENTIC AND HONEST

AUTHENTICITY RESONATES WITH READERS. DON'T BE AFRAID TO SHARE YOUR VULNERABILITIES OR STRUGGLES. THIS CAN HELP CREATE A GENUINE CONNECTION WITH THE ADMISSIONS COMMITTEE.

### 3. SHOW, DON'T JUST TELL

INSTEAD OF MERELY STATING YOUR QUALITIES OR ACCOMPLISHMENTS, ILLUSTRATE THEM THROUGH SPECIFIC EXAMPLES. USE DESCRIPTIVE LANGUAGE AND ANECDOTES TO BRING YOUR EXPERIENCES TO LIFE.

### 4. CONNECT YOUR EXPERIENCES TO YOUR GOALS

CLEARLY ARTICULATE HOW YOUR PAST EXPERIENCES HAVE SHAPED YOUR ASPIRATIONS IN LAW. MAKE CONNECTIONS BETWEEN YOUR PERSONAL NARRATIVE AND YOUR PROFESSIONAL GOALS TO CREATE A COHESIVE STORY.

### 5. EDIT AND REVISE THOROUGHLY

A POLISHED ESSAY IS CRUCIAL. AFTER DRAFTING YOUR ESSAY, TAKE THE TIME TO REVISE AND EDIT CAREFULLY. CONSIDER THE FOLLOWING STEPS:

- SEEK FEEDBACK FROM TRUSTED PEERS OR MENTORS.
- READ YOUR ESSAY ALOUD TO CATCH AWKWARD PHRASING.
- CHECK FOR GRAMMATICAL ERRORS AND ENSURE CLARITY OF EXPRESSION.

## EXAMPLES OF THEMES FROM SUCCESSFUL ESSAYS
