HISTORICAL BACKGROUND AND AUTHORSHIP

THE CREATION OF A CLASSICAL DICTIONARY OF THE VULGAR TONGUE DATES BACK TO THE EARLY 18TH CENTURY, A PERIOD MARKED BY RAPID URBANIZATION AND SOCIAL CHANGE IN ENGLAND. FRANCIS GROSE: THE COMPILER

FRANCIS GROSE WAS AN ENGLISH ANTIQUARIAN AND WRITER WHO SPECIALIZED IN THE DOCUMENTATION OF HISTORICAL CUSTOMS, LANGUAGE, AND ARCHITECTURE. CONTEXT OF 18TH CENTURY ENGLAND

THE 18TH CENTURY WAS A TIME OF SIGNIFICANT SOCIAL STRATIFICATION, WITH CLEAR DIVISIONS BETWEEN THE UPPER CLASSES AND THE WORKING OR LOWER CLASSES.
