5. **LIKING:** WE ARE MORE EASILY PERSUADED BY PEOPLE WE LIKE OR THOSE WHO ARE SIMILAR TO US.
6. **SCARCITY:** THE PERCEPTION THAT SOMETHING IS IN LIMITED SUPPLY INCREASES ITS DESIRABILITY.

THESE PRINCIPLES ARE NOT ONLY THEORETICAL; THEY MANIFEST IN EVERYDAY ADVERTISING, POLITICAL CAMPAIGNS, AND EVEN PERSONAL INTERACTIONS.

THE ROLE OF MEDIA IN PROPAGANDA

THE MEDIA PLAYS A PIVOTAL ROLE IN THE DISSEMINATION OF PROPAGANDA. IN THE AGE OF PROPAGANDA, VARIOUS FORMS OF MEDIA, INCLUDING TELEVISION, RADIO, PRINT, AND DIGITAL PLATFORMS, SERVE AS CONDUITS FOR PERSUASIVE MESSAGES.
