SPECIFIC CHEATING ALLEGATIONS AND SCANDALS

- **MONETARY FINES:** FINANCIAL PENALTIES PAID TO THE NCAA OR RELATED ORGANIZATIONS.

THE IMPACT ON ALABAMA FOOTBALL'S REPUTATION AND LEGACY

MEASURES TAKEN TO ENSURE COMPLIANCE AND INTEGRITY
