UNDERSTANDING THE ALLEGORY OF THE CAVE

WHO ARE THE MAIN CHARACTERS IN THE ALLEGORY?

THE PRIMARY FIGURES INCLUDE THE PRISONERS, THE FREED PRISONER, THE PUPPETEERS CASTING SHADOWS, AND THE FIRE.
