- REFERENCE LIST: AT THE END OF THE MANUSCRIPT, A COMPLETE LIST OF REFERENCES MUST BE PROVIDED IN NUMERIC ORDER, FORMATTED ACCORDING TO AMA GUIDELINES. EACH REFERENCE SHOULD CONTAIN SPECIFIC DETAILS SUCH AS AUTHORS, TITLE, JOURNAL NAME, VOLUME, PAGES, AND PUBLICATION YEAR.

3. ETHICAL CONSIDERATIONS
