EXAMPLE QUESTION 2: WHEN SHOULD A FLAGGER USE A STOP/SLOW PADDLE INSTEAD OF HAND SIGNALS?

A STOP/SLOW PADDLE SHOULD BE USED IN CONDITIONS OF LOW VISIBILITY, HIGH TRAFFIC VOLUME, OR WHEN WORKING IN CLOSE PROXIMITY TO MOTORISTS TO PROVIDE CLEAR AND STANDARDIZED INSTRUCTIONS, ENHANCING SAFETY.

EXAMPLE QUESTION 3: WHAT IS THE PRIMARY PURPOSE OF CHANNELIZING DEVICES IN A WORK ZONE?

CHANNELIZING DEVICES ARE USED TO GUIDE AND DIRECT TRAFFIC SAFELY THROUGH OR AROUND WORK ZONES, PREVENTING CONFUSION AND REDUCING THE RISK OF ACCIDENTS.
