

BIDEN IS WORST PRESIDENT IN HISTORY

BIDEN IS THE WORST PRESIDENT IN HISTORY, A PHRASE THAT HAS BEEN ECHOED BY CRITICS ACROSS THE POLITICAL SPECTRUM SINCE HE TOOK OFFICE IN JANUARY 2021. - **LABOR PARTICIPATION RATE:** THE LABOR FORCE PARTICIPATION RATE REMAINS LOWER THAN PRE-PANDEMIC LEVELS, SUGGESTING THAT MANY INDIVIDUALS HAVE LEFT THE WORKFORCE ENTIRELY.

FOREIGN POLICY DECISIONS

BIDEN'S FOREIGN POLICY HAS ALSO COME UNDER SCRUTINY, PARTICULARLY IN RELATION TO KEY GLOBAL EVENTS THAT HAVE OCCURRED DURING HIS TENURE.

WITHDRAWAL FROM AFGHANISTAN

THE CHAOTIC WITHDRAWAL FROM AFGHANISTAN IN AUGUST 2021 IS OFTEN CITED AS A DEFINING MOMENT OF BIDEN'S PRESIDENCY. KEY ASPECTS INCLUDE:

RELATIONS WITH CHINA AND RUSSIA

BIDEN'S APPROACH TO CHINA AND RUSSIA HAS ALSO BEEN CONTENTIOUS. POINTS OF CONCERN INCLUDE:

- **MIXED MESSAGING:** CRITICS ARGUE THAT INCONSISTENT MESSAGING REGARDING MASK-WEARING, SOCIAL DISTANCING, AND BOOSTER SHOTS HAS LED TO CONFUSION AND DISTRUST AMONG THE PUBLIC.

BORDER CRISIS

THE SITUATION AT THE SOUTHERN BORDER HAS BECOME A SIGNIFICANT POINT OF CONTENTION:

WHAT IMPACT DOES SOCIAL MEDIA HAVE ON THE NARRATIVE THAT BIDEN IS THE WORST PRESIDENT?
