POST-CIVIL WAR DEVELOPMENTS

- SHARECROPPING SYSTEM: MANY FREED SLAVES BECAME SHARECROPPERS, WORKING LAND THEY DID NOT OWN AND OFTEN FALLING INTO CYCLES OF DEBT AND EXPLOITATION.
- JIM CROW LAWS: LEGAL SEGREGATION AND DISCRIMINATORY LAWS FURTHER RESTRICTED ECONOMIC OPPORTUNITIES FOR AFRICAN AMERICANS, ENTRENCHING POVERTY AND LIMITING ACCESS TO EDUCATION AND EMPLOYMENT.
- GREAT MIGRATION: MANY AFRICAN AMERICANS MOVED NORTH IN SEARCH OF BETTER OPPORTUNITIES, BUT THEY OFTEN ENCOUNTERED RACIAL DISCRIMINATION IN LABOR MARKETS AND HOUSING, FURTHER ENTRENCHING ECONOMIC DISPARITIES.

SYSTEMIC INEQUALITY IN THE MODERN ERA

ACCESS TO EDUCATION AND RESOURCES
