 - CONTROL FEDERAL SPENDING AND TAXATION
 - RATIFY TREATIES
 - CONFIRM PRESIDENTIAL APPOINTMENTS
- STRUCTURE:
 - SENATE: COMPOSED OF 100 MEMBERS, WITH TWO SENATORS FROM EACH STATE SERVING SIX-YEAR TERMS.
 - HOUSE OF REPRESENTATIVES: COMPOSED OF 435 MEMBERS WHOSE REPRESENTATION IS BASED ON POPULATION, SERVING

TWO-YEAR TERMS.

- IMPORTANT FUNCTIONS:
- CONDUCTING INVESTIGATIONS AND HEARINGS
- IMPEACHING FEDERAL OFFICIALS
- REDISTRICTING AND APPORTIONMENT

3. THE JUDICIAL BRANCH

THE JUDICIAL BRANCH INTERPRETS LAWS AND ENSURES JUSTICE. IT COMPRISES THE SUPREME COURT AND LOWER FEDERAL COURTS.

- ROLES AND RESPONSIBILITIES:
- INTERPRETS THE CONSTITUTION AND FEDERAL LAWS
- RESOLVES DISPUTES INVOLVING STATES AND THE FEDERAL GOVERNMENT
- REVIEWS LOWER COURT DECISIONS
- KEY COMPONENTS:
- SUPREME COURT: THE HIGHEST COURT IN THE LAND, CONSISTING OF NINE JUSTICES WHO SERVE LIFETIME APPOINTMENTS.
- FEDERAL COURTS: INCLUDE COURTS OF APPEALS, DISTRICT COURTS, AND SPECIALIZED COURTS LIKE THE TAX COURT.
- JUDICIAL REVIEW:
- THE POWER OF THE COURTS TO DECLARE LAWS AND EXECUTIVE ACTIONS UNCONSTITUTIONAL.

IMPORTANCE OF THE SEPARATION OF POWERS

THE SEPARATION OF POWERS IS A FUNDAMENTAL PRINCIPLE OF DEMOCRACY THAT ENSURES NO SINGLE ENTITY HOLDS ABSOLUTE POWER. EACH BRANCH CAN CHECK THE OTHERS, THEREBY MAINTAINING A BALANCE THAT PROTECTS CITIZENS' RIGHTS AND LIBERTIES.

- JUDICIAL CHECKS ON BOTH: COURTS CAN STRIKE DOWN LAWS OR EXECUTIVE ACTIONS THAT VIOLATE THE CONSTITUTION.
- HISTORICAL CONTEXT:
- THE FRAMERS OF THE CONSTITUTION WERE INFLUENCED BY ENLIGHTENMENT THINKERS LIKE MONTESQUIEU, WHO ADVOCATED FOR A SEPARATION OF POWERS TO PREVENT TYRANNY.

- CONGRESS: FOUND VERTICALLY IN COLUMN 5, STARTING FROM ROW 2.
- SUPREME COURT: FOUND DIAGONALLY, FROM ROW 8, COLUMN 4 TO ROW 5, COLUMN 7.
- LEGISLATION: FOUND HORIZONTALLY IN ROW 1, STARTING FROM COLUMN 10.
- IMPEACHMENT: FOUND VERTICALLY IN COLUMN 8, STARTING FROM ROW 6.
- JUDICIARY: FOUND HORIZONTALLY IN ROW 4, STARTING FROM COLUMN 2.
- CABINET: FOUND DIAGONALLY FROM ROW 9, COLUMN 10 TO ROW 6, COLUMN 7.
- SENATE: FOUND VERTICALLY IN COLUMN 3, STARTING FROM ROW 1.
- HOUSE: FOUND HORIZONTALLY IN ROW 2, STARTING FROM COLUMN 6.
- CHECKS AND BALANCES: FOUND HORIZONTALLY IN ROW 7, SPANNING COLUMNS 1 TO 16.
- VETO: FOUND VERTICALLY IN COLUMN 9, STARTING FROM ROW 5.
- LAWS: FOUND DIAGONALLY FROM ROW 10, COLUMN 1 TO ROW 7, COLUMN 4.
- JUSTICE: FOUND VERTICALLY IN COLUMN 11, STARTING FROM ROW 4.
- FEDERAL: FOUND HORIZONTALLY IN ROW 6, STARTING FROM COLUMN 8.
- CONSTITUTION: FOUND DIAGONALLY FROM ROW 2, COLUMN 2 TO ROW 10, COLUMN 10.
