- KEY PRACTICES INCLUDE:
 - ARTICULATING CONCLUSIONS BASED ON EVIDENCE.
 - ENGAGING IN DISCUSSIONS AND DEBATES ABOUT SOCIAL ISSUES.
 - TAKING INFORMED ACTION TO ADDRESS CIVIC CHALLENGES.
