4. **EXAMINATION:** CANDIDATES MUST PASS THE C36 EXAMINATION, WHICH TESTS THEIR KNOWLEDGE OF PLUMBING CODES, REGULATIONS, AND PRACTICES.
5. **BACKGROUND CHECK:** A CRIMINAL BACKGROUND CHECK IS CONDUCTED AS PART OF THE APPLICATION PROCESS.

THE C36 EXAMINATION PROCESS

THE C36 EXAMINATION CONSISTS OF TWO PARTS: THE LAW AND BUSINESS EXAM AND THE C36-SPECIFIC EXAM. UNDERSTANDING THE STRUCTURE AND CONTENT OF THESE EXAMS IS CRUCIAL FOR SUCCESS.

SCORING AND PASSING REQUIREMENTS

TO PASS EACH EXAM, CANDIDATES MUST ACHIEVE A MINIMUM SCORE OF 70%. IF AN APPLICANT FAILS ONE OR BOTH PARTS, THEY MUST WAIT AT LEAST 14 DAYS BEFORE RETAKING THE EXAM. CANDIDATES CAN TAKE THE EXAMS IN ANY ORDER.

KEY TOPICS TO STUDY FOR THE C36 EXAM

PREPARING FOR TEST DAY

AS YOUR EXAM DATE APPROACHES, IT'S ESSENTIAL TO PREPARE NOT ONLY ACADEMICALLY BUT ALSO MENTALLY AND PHYSICALLY.

REVIEW EXAM LOGISTICS
