3. **PERFORMANCE TEST (PT):** THE PERFORMANCE TEST EVALUATES PRACTICAL SKILLS BY REQUIRING CANDIDATES TO COMPLETE A TASK THAT A NEWLY LICENSED ATTORNEY MIGHT ENCOUNTER. THIS MAY INVOLVE DRAFTING A LEGAL DOCUMENT OR ANALYZING A CASE FILE. THE PT CONSTITUTES 20% OF THE TOTAL SCORE.
