IMPORTANCE OF THE C20 LICENSE

4. **ACCESS TO PROJECTS:** MANY CONTRACTS, ESPECIALLY GOVERNMENT OR COMMERCIAL PROJECTS, REQUIRE LICENSED CONTRACTORS.

REQUIREMENTS FOR OBTAINING THE C20 LICENSE
