UNDERSTANDING CALIFORNIA DENTAL HYGIENE LAWS

CALIFORNIA'S DENTAL HYGIENE LAWS ARE ESTABLISHED TO PROTECT THE PUBLIC AND ENSURE THAT DENTAL HYGIENISTS PRACTICE SAFELY AND ETHICALLY. THESE LAWS ARE GOVERNED BY VARIOUS REGULATORY BODIES, PRIMARILY THE DENTAL BOARD OF CALIFORNIA (DBC).

KEY REGULATORY BODIES

1. DENTAL BOARD OF CALIFORNIA (DBC): THIS BOARD IS RESPONSIBLE FOR LICENSING DENTAL HYGIENISTS AND ENSURING COMPLIANCE WITH STATE LAWS.
2. CALIFORNIA DEPARTMENT OF CONSUMER AFFAIRS (DCA): OVERSEES THE DBC AND CONTRIBUTES TO CONSUMER PROTECTION AND REGULATORY PRACTICES.
3. CALIFORNIA DENTAL HYGIENE ASSOCIATION (CDHA): ADVOCATES FOR DENTAL HYGIENE PRACTICE AND PROVIDES RESOURCES FOR PROFESSIONALS.

LICENSING REQUIREMENTS

TO PRACTICE AS A DENTAL HYGIENIST IN CALIFORNIA, CANDIDATES MUST MEET SPECIFIC LICENSING REQUIREMENTS:

- EDUCATIONAL QUALIFICATIONS: CANDIDATES MUST GRADUATE FROM AN ACCREDITED DENTAL HYGIENE PROGRAM.
- NATIONAL BOARD DENTAL HYGIENE EXAMINATION: PASSING THIS EXAM IS NECESSARY BEFORE APPLYING FOR A STATE LICENSE.

ETHICAL PRINCIPLES IN DENTAL HYGIENE

CORE ETHICAL PRINCIPLES

- AUTONOMY: RESPECTING A PATIENT'S RIGHT TO MAKE INFORMED DECISIONS ABOUT THEIR CARE.
- BENEFICENCE: THE OBLIGATION TO ACT IN THE BEST INTEREST OF THE PATIENT.
- NON-MALEFICENCE: THE COMMITMENT TO DO NO HARM TO PATIENTS.

- JUSTICE: ENSURING FAIRNESS IN THE DISTRIBUTION OF DENTAL CARE AND RESOURCES.
- VERACITY: UPHOLDING HONESTY AND TRANSPARENCY IN ALL PATIENT INTERACTIONS.

PROFESSIONAL CONDUCT AND BEHAVIOR

DENTAL HYGIENISTS ARE EXPECTED TO ADHERE TO HIGH STANDARDS OF PROFESSIONAL CONDUCT, WHICH INCLUDE:

- MAINTAINING PATIENT CONFIDENTIALITY.
- PROVIDING INFORMED CONSENT PRIOR TO TREATMENT.
- ENGAGING IN CONTINUING EDUCATION TO STAY UPDATED ON BEST PRACTICES AND LEGAL CHANGES.
- REPORTING UNETHICAL BEHAVIOR AND PRACTICES WITHIN THE DENTAL PROFESSION.

PREPARING FOR THE EXAMINATION
