CE UNITS REQUIRED

- DENTISTS: MUST COMPLETE A MINIMUM OF 50 HOURS OF CE EVERY TWO YEARS.
- REGISTERED DENTAL HYGIENISTS: REQUIRED TO COMPLETE 30 HOURS OF CE EVERY TWO YEARS.
- REGISTERED DENTAL ASSISTANTS: REQUIRED TO COMPLETE 25 HOURS OF CE EVERY TWO YEARS.

TYPES OF CE COURSES

CE COURSES CAN COVER A WIDE RANGE OF TOPICS, INCLUDING BUT NOT LIMITED TO:

- CLINICAL PRACTICES
- ETHICS AND LAW
- INFECTION CONTROL
- PAIN MANAGEMENT
- PATIENT SAFETY

OPTIONS FOR FREE CE IN CALIFORNIA
