PROPER PARKING IS ESSENTIAL TO AVOID PENALTIES OR ACCIDENTS. STUDY THE FOLLOWING REGULATIONS:

- WHERE AND HOW TO PARK LEGALLY
- UNDERSTANDING DISABLED PARKING REQUIREMENTS
- THE IMPORTANCE OF CURB MARKINGS

EFFECTIVE STUDY STRATEGIES
