5. **COURT FILINGS:** FILING DOCUMENTS WITH THE COURT AND ENSURING COMPLIANCE WITH LOCAL RULES AND DEADLINES.

4. DISCOVERY PHASE

DISCOVERY IS A CRITICAL STAGE WHERE BOTH PARTIES EXCHANGE INFORMATION. PARALEGALS ARE INSTRUMENTAL IN:

- DRAFTING DISCOVERY REQUESTS SUCH AS INTERROGATORIES, REQUESTS FOR PRODUCTION, AND REQUESTS FOR ADMISSIONS.
- ORGANIZING AND REVIEWING DOCUMENTS PRODUCED DURING DISCOVERY.
- PREPARING FOR DEPOSITIONS.

5. TRIAL PREPARATION

AS THE CASE MOVES TOWARD TRIAL, PARALEGALS ASSIST ATTORNEYS IN PREPARING:

- TRIAL BRIEFS AND JURY INSTRUCTIONS.
- EXHIBITS AND DEMONSTRATIVE EVIDENCE.
- WITNESS LISTS AND TRIAL STRATEGIES.

6. TRIAL AND POST-TRIAL

DURING THE TRIAL, PARALEGALS MAY HELP BY:

- TAKING NOTES AND TRACKING EVIDENCE PRESENTED.
- ASSISTING WITH JURY SELECTION.
- PREPARING POST-TRIAL MOTIONS OR APPEALS IF NECESSARY.
