GRADUATE AND PROFESSIONAL DEGREES

ADVANCED CAREERS DEMAND GRADUATE EDUCATION SUCH AS A JURIS DOCTOR (JD) FOR LEGAL PRACTICE OR A MASTER'S/DOCTORATE IN PSYCHOLOGY FOR CLINICAL OR FORENSIC ROLES. SPECIALIZATIONS IN FORENSIC PSYCHOLOGY,

CLINICAL PSYCHOLOGY, OR LEGAL PSYCHOLOGY FURTHER ENHANCE EXPERTISE.

LICENSURE AND CERTIFICATION

MANY CAREERS REQUIRE OBTAINING PROFESSIONAL LICENSES. LAWYERS MUST PASS THE BAR EXAM, WHILE PSYCHOLOGISTS NEED STATE LICENSURE TO PRACTICE CLINICALLY. ADDITIONAL CERTIFICATIONS IN FORENSIC PSYCHOLOGY OR MEDIATION MAY BE ADVANTAGEOUS.

KEY CAREER ROLES COMBINING LAW AND PSYCHOLOGY

THE FUSION OF LAW AND PSYCHOLOGY CREATES NUMEROUS SPECIALIZED ROLES THAT CONTRIBUTE UNIQUELY TO THE JUSTICE SYSTEM AND MENTAL HEALTH SERVICES. BELOW ARE SOME PROMINENT CAREER OPTIONS:

FORENSIC PSYCHOLOGIST

FORENSIC PSYCHOLOGISTS APPLY PSYCHOLOGICAL PRINCIPLES TO LEGAL ISSUES, OFTEN ASSESSING DEFENDANTS' MENTAL STATE, COMPETENCY TO STAND TRIAL, AND RISK OF REOFFENDING. THEY PROVIDE EXPERT TESTIMONY AND ASSIST LAW ENFORCEMENT IN CRIMINAL PROFILING.

CRIMINAL PROFILER

CRIMINAL PROFILERS ANALYZE BEHAVIORAL PATTERNS TO ASSIST LAW ENFORCEMENT AGENCIES IN IDENTIFYING AND APPREHENDING SUSPECTS. THIS ROLE REQUIRES DEEP KNOWLEDGE OF PSYCHOLOGY AND CRIMINAL BEHAVIOR.

LEGAL PSYCHOLOGIST

LEGAL PSYCHOLOGISTS STUDY THE PSYCHOLOGICAL ASPECTS OF LEGAL PROCESSES, INCLUDING JURY DECISION-MAKING, EYEWITNESS TESTIMONY RELIABILITY, AND INTERROGATION TECHNIQUES. THEIR RESEARCH INFORMS LEGAL PRACTICES AND POLICIES.

LAWYER SPECIALIZING IN MENTAL HEALTH LAW

THESE PROFESSIONALS USE PSYCHOLOGICAL INSIGHTS TO FACILITATE NEGOTIATION AND DISPUTE RESOLUTION OUTSIDE OF COURT, PROMOTING AMICABLE SETTLEMENTS AND REDUCING LITIGATION COSTS.

VICTIM ADVOCATE

VICTIM ADVOCATES SUPPORT INDIVIDUALS AFFECTED BY CRIME, OFFERING COUNSELING, RESOURCES, AND ASSISTANCE NAVIGATING THE LEGAL SYSTEM. THEIR WORK COMBINES EMPATHY WITH KNOWLEDGE OF LEGAL RIGHTS AND PROCEDURES.
