TIPS FOR SUCCESS ON THE CASA MATH TEST

IN SOME CASES, ESTIMATION CAN SAVE TIME AND HELP YOU IDENTIFY THE MOST PLAUSIBLE ANSWER QUICKLY. IF THE QUESTION ALLOWS FOR IT, ROUND NUMBERS TO SIMPLIFY CALCULATIONS.

4. MANAGE YOUR TIME WISELY

KEEP AN EYE ON THE CLOCK DURING THE TEST. ALLOCATE TIME FOR EACH QUESTION AND MOVE ON IF YOU GET STUCK. YOU CAN ALWAYS RETURN TO DIFFICULT QUESTIONS IF TIME PERMITS.

5. STAY CALM AND CONFIDENT

TEST ANXIETY CAN HINDER PERFORMANCE. PRACTICE RELAXATION TECHNIQUES, SUCH AS DEEP BREATHING OR VISUALIZATION,

TO MAINTAIN CALMNESS DURING THE TEST. CONFIDENCE IN YOUR PREPARATION WILL HELP YOU PERFORM BETTER.
