6. TOXIC AND INFECTIOUS SUBSTANCES (CLASS 6)
7. RADIOACTIVE MATERIALS (CLASS 7)
8. CORROSIVE MATERIALS (CLASS 8)
9. MISCELLANEOUS DANGEROUS GOODS (CLASS 9)

UNDERSTANDING THESE CLASSIFICATIONS IS ESSENTIAL FOR DRIVERS AS THEY IMPACT HANDLING, TRANSPORTATION, AND EMERGENCY RESPONSE PROCEDURES.

ELIGIBILITY REQUIREMENTS FOR A HAZMAT ENDORSEMENT

BEFORE APPLYING FOR A HAZMAT ENDORSEMENT, YOU MUST MEET SPECIFIC ELIGIBILITY CRITERIA. HERE ARE THE GENERAL REQUIREMENTS:
