- CERTIFIED STERILE PROCESSING AND DISTRIBUTION TECHNICIAN (CSPDT): PROVIDED BY THE CERTIFICATION BOARD FOR STERILE PROCESSING AND DISTRIBUTION (CBSPD), THIS CERTIFICATION FOCUSES ON STERILIZATION PROCESSES AND PROCEDURES.

CERTIFICATION TYPICALLY REQUIRES PASSING AN EXAM AND MAY NECESSITATE CONTINUING EDUCATION CREDITS TO MAINTAIN THE CREDENTIAL.

WHAT IS THE AVERAGE SALARY FOR A CENTRAL PROCESSING TECHNICIAN IN MASSACHUSETTS?

AS OF 2023, THE AVERAGE SALARY FOR A CENTRAL PROCESSING TECHNICIAN IN MASSACHUSETTS RANGES FROM \$40,000 TO \$55,000 PER YEAR, DEPENDING ON EXPERIENCE AND LOCATION.
