4. **SURVIVAL OF THE FITTEST:** THIS PHRASE DESCRIBES THE PROCESS OF NATURAL SELECTION, WHERE "FITTEST" REFERS TO THOSE INDIVIDUALS BEST SUITED TO THEIR ENVIRONMENT, NOT NECESSARILY THE STRONGEST.
5. **DESCENT WITH MODIFICATION:** THIS CONCEPT SUGGESTS THAT SPECIES EVOLVE OVER TIME, AND NEWER SPECIES ARE MODIFIED DESCENDANTS OF OLDER SPECIES.

HISTORICAL CONTEXT OF EVOLUTION

PRE-DARWINIAN THEORIES

- LAMARCKISM: JEAN-BAPTISTE LAMARCK PROPOSED THAT ORGANISMS COULD PASS ON TRAITS ACQUIRED DURING THEIR LIFETIME TO THEIR OFFSPRING (E.G., GIRAFFES STRETCHING THEIR NECKS).
- GEOLOGICAL DISCOVERIES: THE WORK OF GEOLOGISTS LIKE CHARLES LYELL SUGGESTED THAT EARTH WAS MUCH OLDER THAN PREVIOUSLY THOUGHT, PROVIDING A TIMELINE FOR GRADUAL EVOLUTIONARY CHANGE.

EVIDENCE FOR EVOLUTION

THE THEORY OF EVOLUTION IS SUPPORTED BY MULTIPLE LINES OF EVIDENCE, WHICH CAN BE CATEGORIZED AS FOLLOWS:

FOSSIL EVIDENCE

- HOMOLOGOUS STRUCTURES: THESE ARE ANATOMICAL FEATURES IN DIFFERENT SPECIES THAT SHARE A COMMON ANCESTRY, SUCH AS THE FORELIMBS OF MAMMALS.
- ANALOGOUS STRUCTURES: FEATURES THAT SERVE SIMILAR FUNCTIONS BUT EVOLVED INDEPENDENTLY, SUCH AS THE WINGS OF BIRDS AND INSECTS, HIGHLIGHT THE ROLE OF ENVIRONMENTAL PRESSURES IN SHAPING ADAPTATIONS.

MOLECULAR EVIDENCE

- DNA COMPARISONS: GENETIC ANALYSIS HAS REVEALED SIMILARITIES AND DIFFERENCES IN DNA SEQUENCES AMONG SPECIES, PROVIDING INSIGHT INTO THEIR EVOLUTIONARY RELATIONSHIPS.
