2. SHORT ANSWER: THESE REQUIRE MORE DETAILED RESPONSES AND CAN HELP IN ARTICULATING YOUR UNDERSTANDING.
3. ESSAY QUESTIONS: THESE ALLOW FOR IN-DEPTH EXPLORATION OF CONCEPTS, REQUIRING YOU TO SYNTHESIZE INFORMATION AND PRESENT ARGUMENTS.

GROUP STUDY SESSIONS
