4. KEEP RECORDS: MAINTAIN COPIES OF ALL CORRESPONDENCE AND DOCUMENTATION RELATED TO THE CLASS ACTION FOR YOUR RECORDS.

COMMON TYPES OF CLASS ACTIONS AGAINST CHASE

THERE HAVE BEEN VARIOUS TYPES OF CLASS ACTIONS FILED AGAINST JPMORGAN CHASE, INCLUDING:

3. DISBURSEMENT: ELIGIBLE MEMBERS WILL RECEIVE COMPENSATION AS DETERMINED BY THE SETTLEMENT AGREEMENT.

IMPORTANT DEADLINES

MAKE SURE TO BE AWARE OF CRITICAL DEADLINES DURING THE CLAIMS PROCESS:

- CLAIM SUBMISSION DEADLINES: THESE ARE THE LAST DATES YOU CAN SUBMIT YOUR CLAIM FORMS.
- OPT-OUT DEADLINES: IF YOU CHOOSE NOT TO PARTICIPATE IN THE CLASS ACTION, YOU MUST NOTIFY THE COURT BY A SPECIFIED DATE.
- SETTLEMENT APPROVAL HEARINGS: ATTEND OR FOLLOW UP ON THE OUTCOMES OF HEARINGS WHERE THE COURT REVIEWS AND APPROVES SETTLEMENTS.
