- TECHNIQUES FOR MITIGATING RISKS

3. GOVERNANCE

GOVERNANCE ENCOMPASSES THE FRAMEWORKS AND PROCESSES THAT ENSURE ACCOUNTABILITY AND TRANSPARENCY WITHIN AN ORGANIZATION. KEY ASPECTS INCLUDE:

- CORPORATE GOVERNANCE PRINCIPLES
- THE ROLE OF THE BOARD OF DIRECTORS
- COMPLIANCE WITH LAWS AND REGULATIONS

4. INTERNAL CONTROL

INTERNAL CONTROLS ARE ESSENTIAL FOR ENSURING THE INTEGRITY OF FINANCIAL REPORTING AND OPERATIONAL EFFICIENCY. KEY TOPICS INCLUDE:
