4. CONFIDENTIALITY AND DATA SECURITY

PROTECTING PARTICIPANT DATA IS ESSENTIAL FOR MAINTAINING TRUST AND COMPLYING WITH ETHICAL STANDARDS. TOPICS INCLUDE:

- METHODS FOR ENSURING CONFIDENTIALITY.
- DATA STORAGE AND SECURITY MEASURES.
- ETHICAL CONSIDERATIONS WHEN REPORTING DATA.

NAVIGATING THE IRB PROCESS

THE INSTITUTIONAL REVIEW BOARD (IRB) PLAYS A VITAL ROLE IN OVERSEEING RESEARCH INVOLVING HUMAN PARTICIPANTS. UNDERSTANDING THE IRB PROCESS IS CRUCIAL FOR RESEARCHERS.

1. PREPARING YOUR SUBMISSION

RESEARCHERS MUST PREPARE A THOROUGH SUBMISSION FOR IRB REVIEW, INCLUDING:

- A CLEAR RESEARCH PROPOSAL OUTLINING OBJECTIVES AND METHODS.
- CONSENT FORMS THAT ADHERE TO ETHICAL GUIDELINES.
- AN ASSESSMENT OF POTENTIAL RISKS AND BENEFITS.

2. UNDERSTANDING REVIEW TYPES

IRB REVIEWS CAN VARY BASED ON THE LEVEL OF RISK ASSOCIATED WITH THE RESEARCH:

- EXEMPT REVIEW: STUDIES THAT POSE MINIMAL RISK AND FIT SPECIFIC CATEGORIES.
- EXPEDITED REVIEW: RESEARCH INVOLVING ONLY MINIMAL RISK AND MEETING CERTAIN CRITERIA.
- FULL BOARD REVIEW: REQUIRED FOR STUDIES THAT POSE MORE THAN MINIMAL RISK.

3. RESPONDING TO IRB FEEDBACK

RESEARCHERS SHOULD BE PREPARED TO ADDRESS FEEDBACK FROM THE IRB, WHICH MAY INCLUDE:

- MODIFICATIONS TO THE STUDY DESIGN.
- ADDITIONAL SAFEGUARDS FOR PARTICIPANT PROTECTION.
- CLARIFICATIONS REGARDING CONSENT PROCESSES.

COMMON QUESTIONS AND ANSWERS FROM CITI TRAINING

3. CAN I TAKE CITI TRAINING ONLINE?

YES, CITI TRAINING IS ENTIRELY ONLINE AND CAN BE COMPLETED AT YOUR OWN PACE, MAKING IT ACCESSIBLE FOR BUSY RESEARCHERS.

HOW CAN RESEARCHERS STAY CURRENT WITH CHANGES IN ETHICAL GUIDELINES AFTER COMPLETING CITI TRAINING?

RESEARCHERS CAN STAY CURRENT BY SUBSCRIBING TO UPDATES FROM REGULATORY BODIES, PARTICIPATING IN WORKSHOPS, AND COMPLETING ADDITIONAL CITI MODULES AS THEY BECOME AVAILABLE.
