## RIGHTS OF CITIZENS

## REQUIREMENTS FOR NATURALIZATION

4. GOOD MORAL CHARACTER: MUST DEMONSTRATE GOOD MORAL CHARACTER DURING THE RESIDENCY PERIOD.
5. ENGLISH LANGUAGE PROFICIENCY: MUST BE ABLE TO READ, WRITE, AND SPEAK BASIC ENGLISH.
6. KNOWLEDGE OF U.S. HISTORY AND GOVERNMENT: MUST PASS A CIVICS TEST COVERING U.S. HISTORY AND GOVERNMENT.

## THE NATURALIZATION PROCESS STEPS

THE PROCESS OF NATURALIZATION TYPICALLY INVOLVES THE FOLLOWING STEPS:

1. COMPLETE FORM N-400: THE APPLICATION FOR NATURALIZATION IS THE FIRST STEP.
2. BIOMETRICS APPOINTMENT: APPLICANTS ARE REQUIRED TO PROVIDE FINGERPRINTS FOR A BACKGROUND CHECK.
3. INTERVIEW: AN INTERVIEW WITH A USCIS OFFICER TO DISCUSS THE APPLICATION AND TEST ENGLISH AND CIVICS KNOWLEDGE.
4. OATH OF ALLEGIANCE: IF APPROVED, THE FINAL STEP IS TAKING THE OATH OF ALLEGIANCE TO BECOME A U.S. CITIZEN.
