- SEPARATION OF POWERS
- CHECKS AND BALANCES
- RIGHTS AND RESPONSIBILITIES
- BILL OF RIGHTS
- RESPONSIBILITIES OF CITIZENSHIP
- VOTING RIGHTS

2. ENGLISH TEST

THE ENGLISH TEST EVALUATES AN APPLICANT'S ABILITY TO READ, WRITE, AND SPEAK IN ENGLISH. THIS COMPONENT COMPRISES THREE PARTS:

- SPEAKING: A USCIS OFFICER ASSESSES THE APPLICANT'S ABILITY TO COMMUNICATE IN ENGLISH DURING THE INTERVIEW.
- READING: APPLICANTS MUST READ ONE OUT OF THREE SENTENCES CORRECTLY TO DEMONSTRATE READING PROFICIENCY.
