DONOR RECRUITMENT AND SCREENING IN BLOOD BANKING

CRITERIA FOR DONOR ELIGIBILITY

STORAGE REQUIREMENTS AND SHELF LIFE

PROPER STORAGE CONDITIONS ARE CRITICAL TO THE EFFICACY AND SAFETY OF BLOOD COMPONENTS. FOR EXAMPLE, RED BLOOD CELLS ARE TYPICALLY STORED AT $1-6^{\circ}\text{C}$ FOR UP TO 42 DAYS, WHILE PLATELETS REQUIRE ROOM TEMPERATURE STORAGE WITH CONSTANT AGITATION AND HAVE A SHORTER SHELF LIFE OF 5 DAYS. PLASMA IS FROZEN PROMPTLY AND CAN BE STORED FOR UP TO ONE YEAR. ADHERING TO THESE PARAMETERS REDUCES THE RISK OF HEMOLYSIS, BACTERIAL CONTAMINATION, AND LOSS OF FUNCTION.

COMPATIBILITY TESTING AND CROSSMATCHING PROCEDURES
