4. **CONTINUING EDUCATION:** MAINTAINING YOUR LICENSE REQUIRES ONGOING EDUCATION, HELPING YOU STAY CURRENT WITH ADVANCEMENTS IN THE FIELD AND IMPROVING YOUR SKILLS.

ELIGIBILITY REQUIREMENTS FOR A CONNECTICUT PHYSICAL THERAPY LICENSE

TO BE ELIGIBLE FOR A CONNECTICUT PHYSICAL THERAPY LICENSE, CANDIDATES MUST MEET SPECIFIC EDUCATIONAL AND PROFESSIONAL CRITERIA:

1. EDUCATIONAL BACKGROUND

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE REQUIREMENTS TO OBTAIN A PHYSICAL THERAPY LICENSE IN CONNECTICUT?

TO OBTAIN A PHYSICAL THERAPY LICENSE IN CONNECTICUT, YOU MUST COMPLETE A DOCTOR OF PHYSICAL THERAPY (DPT) PROGRAM FROM AN ACCREDITED INSTITUTION, PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), AND SUBMIT AN APPLICATION ALONG WITH THE REQUIRED FEES TO THE CONNECTICUT DEPARTMENT OF PUBLIC HEALTH.

YES, CANDIDATES MUST PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE) AS PART OF THE LICENSURE PROCESS IN CONNECTICUT.

WHAT IS THE APPLICATION PROCESS FOR A PHYSICAL THERAPY LICENSE IN CONNECTICUT?

THE APPLICATION PROCESS INCLUDES SUBMITTING A COMPLETED APPLICATION FORM, PROVIDING PROOF OF EDUCATION AND NPTE PASSING SCORES, AND PAYING THE REQUIRED APPLICATION FEE TO THE CONNECTICUT DEPARTMENT OF PUBLIC HEALTH.

ARE THERE ANY BACKGROUND CHECK REQUIREMENTS FOR OBTAINING A PHYSICAL THERAPY LICENSE IN CONNECTICUT?

YES, APPLICANTS FOR A PHYSICAL THERAPY LICENSE IN CONNECTICUT ARE REQUIRED TO UNDERGO A CRIMINAL BACKGROUND CHECK AS PART OF THE LICENSURE PROCESS.

WHAT IS THE COST OF OBTAINING A PHYSICAL THERAPY LICENSE IN CONNECTICUT?

THE APPLICATION FEE FOR A PHYSICAL THERAPY LICENSE IN CONNECTICUT IS TYPICALLY AROUND \$200, BUT APPLICANTS SHOULD CHECK THE CONNECTICUT DEPARTMENT OF PUBLIC HEALTH WEBSITE FOR THE MOST CURRENT FEE INFORMATION.
