- **THE CATILINE CONSPIRACY (63 BC):** A PLOT LED BY THE ROMAN SENATOR LUCIUS SERGIUS CATILINA TO OVERTHROW THE ROMAN REPUBLIC. THIS CONSPIRACY WAS EXPOSED BY CICERO, LEADING TO THE EXECUTION OF ITS LEADERS.

FAMOUS SECRET SOCIETIES

NUMEROUS SECRET SOCIETIES HAVE GAINED NOTORIETY OVER THE YEARS, EACH WITH ITS OWN UNIQUE BELIEFS AND PRACTICES.

THE FREEMASONS
