GLENN BECK'S INFLUENCE ON THE GUN CONTROL NARRATIVE

GLENN BECK IS A PROMINENT CONSERVATIVE COMMENTATOR AND MEDIA PERSONALITY KNOWN FOR HIS PASSIONATE VIEWS ON VARIOUS POLITICAL ISSUES, INCLUDING GUN RIGHTS. STATISTICS ON GUN VIOLENCE

- GUN HOMICIDES: ACCORDING TO THE CENTERS FOR DISEASE CONTROL AND PREVENTION (CDC), THERE WERE APPROXIMATELY 19,384 GUN-RELATED HOMICIDES IN THE U.S. IN 2020.
- MASS SHOOTINGS: THE GUN VIOLENCE ARCHIVE REPORTED OVER 600 MASS SHOOTINGS IN THE SAME YEAR, SPARKING NATIONAL OUTRAGE AND CALLS FOR REFORM.
- SUICIDES: A SIGNIFICANT PORTION OF GUN DEATHS ARE SUICIDES, WHICH ACCOUNT FOR MORE THAN HALF OF ALL GUN-RELATED FATALITIES.

ARGUMENTS FOR GUN CONTROL

THOSE IN FAVOR OF STRICTER GUN CONTROL OFTEN CITE SEVERAL KEY ARGUMENTS:

1. PUBLIC SAFETY: ADVOCATES ARGUE THAT TIGHTER REGULATIONS CAN LEAD TO A REDUCTION IN GUN VIOLENCE AND FATALITIES.
2. PREVENTING ACCESS: STRICTER LAWS CAN HELP PREVENT FIREARMS FROM FALLING INTO THE HANDS OF INDIVIDUALS WITH A HISTORY OF VIOLENCE OR MENTAL ILLNESS.

COUNTERARGUMENTS FROM GUN RIGHTS ADVOCATES

CONVERSELY, GUN RIGHTS ADVOCATES PRESENT THEIR OWN ARGUMENTS AGAINST GUN CONTROL MEASURES:

- INEFFECTIVENESS: MANY ARGUE THAT GUN CONTROL LAWS DO NOT EFFECTIVELY PREVENT CRIME, AS CRIMINALS OFTEN DO NOT ADHERE TO LAWS.
- SELF-DEFENSE: THE RIGHT TO SELF-DEFENSE IS OFTEN CITED, WITH ADVOCATES BELIEVING THAT AN ARMED POPULACE CAN DETER CRIME.
