WRITTEN EXAMINATION

- HAIR CUTTING AND STYLING TECHNIQUES
- SKIN CARE AND MAKEUP APPLICATION
- NAIL TECHNOLOGY AND ART

- STATE LAWS AND REGULATIONS REGARDING COSMETOLOGY

PRACTICAL EXAMINATION

PREPARING FOR THE STATE BOARD EXAM

2. CREATE A STUDY PLAN

PRACTICE TESTS AND MOCK EXAMS

TAKING PRACTICE TESTS IS ONE OF THE MOST EFFECTIVE WAYS TO PREPARE FOR THE WRITTEN EXAM. HERE'S HOW TO UTILIZE PRACTICE TESTS TO YOUR ADVANTAGE:

1. SIMULATE EXAM CONDITIONS

3. CREATE A PRACTICE ROUTINE

DEVELOPING A CONSISTENT PRACTICE ROUTINE CAN REINFORCE SKILLS. CANDIDATES SHOULD:

1. FOCUS ON ONE SKILL AT A TIME (E.G., HAIR CUTTING, FACIALS).
2. SET SPECIFIC GOALS FOR EACH PRACTICE SESSION.
3. RECORD PROGRESS TO TRACK IMPROVEMENT OVER TIME.

DAY OF THE EXAM: FINAL TIPS

- IDENTIFICATION
- LICENSING FEES
- COSMETOLOGY KIT (FOR PRACTICAL SKILLS)
- PENS, PENCILS, AND OTHER WRITING IMPLEMENTS

4. STAY POSITIVE

MAINTAIN A POSITIVE MINDSET THROUGHOUT THE EXAM. TAKE DEEP BREATHS, AND IF YOU ENCOUNTER DIFFICULT QUESTIONS OR TASKS, REMEMBER THAT PREPARATION IS KEY.
