- **TECHNICAL PROFICIENCY:** FAMILIARITY WITH VARIOUS TRANSCRIPTION SOFTWARE AND EQUIPMENT IS INCREASINGLY IMPORTANT IN THE DIGITAL AGE.

4. CART PROVIDER

COMMUNICATION ACCESS REALTIME TRANSLATION (CART) PROVIDERS OFFER TRANSCRIPTION SERVICES FOR INDIVIDUALS WHO ARE DEAF OR HARD OF HEARING, ENABLING THEM TO ACCESS SPOKEN CONTENT IN REAL-TIME.

JOB MARKET AND SALARY EXPECTATIONS

THE DEMAND FOR COURT REPORTERS IS EXPECTED TO RISE IN THE COMING YEARS, DRIVEN BY THE NEED FOR ACCURATE LEGAL DOCUMENTATION AND THE EXPANSION OF TECHNOLOGY IN THE INDUSTRY. ACCORDING TO THE U.S. BUREAU OF LABOR STATISTICS, THE MEDIAN ANNUAL WAGE FOR COURT REPORTERS WAS APPROXIMATELY \$61,660 AS OF MAY 2023, WITH THE POTENTIAL FOR HIGHER EARNINGS BASED ON EXPERIENCE AND LOCATION.

IN TEXAS, COURT REPORTERS CAN WORK IN VARIOUS SETTINGS, INCLUDING COURTROOMS, DEPOSITIONS, FREELANCE REPORTING, AND CART (COMMUNICATION ACCESS REAL-TIME TRANSLATION) FOR THE DEAF AND HARD OF HEARING.

WHAT ARE THE COSTS ASSOCIATED WITH COURT REPORTER TRAINING PROGRAMS IN TEXAS?
