QUESTION 3: WHAT IS THE PURPOSE OF FORM W-4?

- ANSWER: FORM W-4 IS USED BY EMPLOYEES TO INDICATE THEIR TAX WITHHOLDING PREFERENCES TO THEIR EMPLOYER. IT HELPS DETERMINE THE AMOUNT OF FEDERAL INCOME TAX TO WITHHOLD FROM THEIR PAYCHECK.

QUESTION 4: WHAT IS THE PENALTY FOR FAILING TO FILE FORM 941 ON TIME?
