WHAT IS A CRIMINAL HISTORY REPORT IN TEXAS?

A CRIMINAL HISTORY REPORT TEXAS IS A DETAILED RECORD COMPILED BY LAW ENFORCEMENT AGENCIES THAT DOCUMENTS AN INDIVIDUAL'S CRIMINAL BACKGROUND. IT TYPICALLY INCLUDES A RANGE OF INFORMATION SUCH AS ARRESTS, CHARGES, CONVICTIONS, AND DISPOSITIONS RELATED TO CRIMINAL CASES WITHIN THE STATE. THESE REPORTS ARE CRUCIAL FOR VERIFYING AN INDIVIDUAL'S LEGAL HISTORY FOR PURPOSES LIKE EMPLOYMENT SCREENING, LICENSING, OR LEGAL PROCEEDINGS. THE TEXAS DEPARTMENT OF PUBLIC SAFETY (DPS) IS A PRIMARY SOURCE FOR CRIMINAL HISTORY INFORMATION IN TEXAS, MAINTAINING STATEWIDE RECORDS ACCESSIBLE TO AUTHORIZED ENTITIES AND INDIVIDUALS.

PURPOSE OF A CRIMINAL HISTORY REPORT

THE PRIMARY PURPOSE OF A CRIMINAL HISTORY REPORT IS TO PROVIDE A COMPREHENSIVE VIEW OF AN INDIVIDUAL'S INTERACTIONS WITH THE CRIMINAL JUSTICE SYSTEM. EMPLOYERS OFTEN USE THESE REPORTS TO ASSESS THE SUITABILITY OF CANDIDATES FOR SENSITIVE POSITIONS. ADDITIONALLY, LANDLORDS, LICENSING AGENCIES, AND VOLUNTEER ORGANIZATIONS MAY REQUIRE ACCESS TO THESE REPORTS TO ENSURE SAFETY AND COMPLIANCE WITH REGULATIONS. THE CRIMINAL HISTORY REPORT TEXAS ALSO AIDS LAW ENFORCEMENT AGENCIES IN INVESTIGATIONS AND HELPS INDIVIDUALS VERIFY THEIR OWN RECORDS FOR ACCURACY OR LEGAL REASONS.

WHO CAN REQUEST A CRIMINAL HISTORY REPORT?

IN TEXAS, CRIMINAL HISTORY REPORTS CAN BE REQUESTED BY VARIOUS PARTIES INCLUDING THE INDIVIDUAL CONCERNED, EMPLOYERS, LAW ENFORCEMENT AGENCIES, ATTORNEYS, AND CERTAIN GOVERNMENT AGENCIES. HOWEVER, ACCESS TO THESE RECORDS IS REGULATED TO PROTECT PRIVACY AND PREVENT MISUSE. FOR EXAMPLE, EMPLOYERS MUST COMPLY WITH THE FAIR CREDIT REPORTING ACT (FCRA) WHEN OBTAINING THESE REPORTS FOR EMPLOYMENT SCREENING PURPOSES, ENSURING PROPER CONSENT AND DISCLOSURE.

How to Obtain a Criminal History Report in Texas

OBTAINING A CRIMINAL HISTORY REPORT IN TEXAS INVOLVES SEVERAL STEPS DEPENDING ON THE REQUESTER AND THE PURPOSE OF THE REPORT. THE TEXAS DEPARTMENT OF PUBLIC SAFETY OFFERS AN ONLINE SERVICE KNOWN AS THE CRIME RECORDS SERVICE (CRS) THROUGH WHICH INDIVIDUALS AND AUTHORIZED ENTITIES CAN REQUEST CRIMINAL HISTORY INFORMATION. ADDITIONALLY, FINGERPRINTING MAY BE REQUIRED FOR MORE DETAILED OR CERTIFIED REPORTS.

REQUESTING THROUGH TEXAS DEPARTMENT OF PUBLIC SAFETY

THE MOST COMMON METHOD TO OBTAIN A CRIMINAL HISTORY REPORT TEXAS IS THROUGH THE TEXAS DPS CRIME RECORDS SERVICE. APPLICANTS CAN SUBMIT A REQUEST ONLINE, BY MAIL, OR IN PERSON. THE PROCESS GENERALLY REQUIRES:

- COMPLETION OF AN APPLICATION FORM
- SUBMISSION OF A FINGERPRINT CARD (FOR DETAILED REPORTS)
- PAYMENT OF A PROCESSING FEE
- PROOF OF IDENTITY

ONCE SUBMITTED, THE DPS PROCESSES THE REQUEST AND PROVIDES THE REPORT, USUALLY WITHIN A FEW BUSINESS DAYS.

ALTERNATIVE METHODS TO OBTAIN REPORTS

BESIDES THE DPS, SOME PRIVATE BACKGROUND CHECK COMPANIES OFFER CRIMINAL HISTORY REPORT SERVICES FOR TEXAS RESIDENTS. HOWEVER, THESE MAY NOT BE AS COMPREHENSIVE OR OFFICIAL AS THE REPORTS OBTAINED DIRECTLY FROM THE DPS. CERTAIN COURTS OR LAW ENFORCEMENT AGENCIES MAY ALSO PROVIDE ACCESS TO LOCAL OR COUNTY-LEVEL CRIMINAL RECORDS.

CONTENTS OF A TEXAS CRIMINAL HISTORY REPORT

A CRIMINAL HISTORY REPORT TEXAS CONTAINS DETAILED INFORMATION ABOUT AN INDIVIDUAL'S CRIMINAL RECORD MAINTAINED BY THE STATE. THE SPECIFIC CONTENTS CAN VARY BUT GENERALLY INCLUDE SEVERAL KEY COMPONENTS THAT PROVIDE A FULL OVERVIEW OF CRIMINAL ACTIVITIES AND LEGAL OUTCOMES.

KEY INFORMATION INCLUDED

THE REPORT TYPICALLY CONTAINS THE FOLLOWING:

- **PERSONAL IDENTIFIERS:** NAME, DATE OF BIRTH, GENDER, AND PHYSICAL CHARACTERISTICS TO ENSURE ACCURATE IDENTIFICATION.
- **ARREST RECORDS:** DATES AND DETAILS OF ARRESTS MADE BY TEXAS LAW ENFORCEMENT AGENCIES.
- **CHARGES FILED:** INFORMATION ABOUT CRIMINAL CHARGES BROUGHT AGAINST THE INDIVIDUAL.
- **CONVICTION DETAILS:** CONVICTION STATUS, DATES, AND SENTENCING INFORMATION INCLUDING FINES, PROBATION, OR INCARCERATION.
- **CASE DISPOSITIONS:** OUTCOMES OF CASES SUCH AS ACQUITTALS, DISMISSALS, OR DEFERRED ADJUDICATIONS.

- **FINGERPRINT DATA:** ASSOCIATED FINGERPRINT RECORDS USED FOR VERIFYING IDENTITY AND LINKING RECORDS.

LIMITATIONS AND EXCLUSIONS

IT IS IMPORTANT TO UNDERSTAND THAT CERTAIN RECORDS MAY NOT APPEAR ON A CRIMINAL HISTORY REPORT DUE TO EXPUNGEMENTS, SEALING OF RECORDS, OR JURISDICTIONAL LIMITATIONS. FEDERAL OFFENSES AND OUT-OF-STATE CRIMES ARE GENERALLY NOT INCLUDED UNLESS THEY HAVE BEEN PROCESSED THROUGH TEXAS COURTS OR LAW ENFORCEMENT.

LEGAL USE AND RESTRICTIONS OF CRIMINAL HISTORY REPORTS

THE USE OF CRIMINAL HISTORY REPORTS TEXAS IS GOVERNED BY STATE AND FEDERAL LAWS DESIGNED TO PROTECT INDIVIDUALS' PRIVACY RIGHTS WHILE BALANCING PUBLIC SAFETY CONCERNS. THERE ARE SPECIFIC RESTRICTIONS ON WHO CAN ACCESS THESE REPORTS AND FOR WHAT PURPOSES THEY CAN BE USED.

PERMITTED USES

COMMON LAWFUL USES OF CRIMINAL HISTORY REPORTS INCLUDE:

- EMPLOYMENT SCREENING, ESPECIALLY FOR POSITIONS INVOLVING VULNERABLE POPULATIONS OR SENSITIVE INFORMATION
- LICENSING AND CERTIFICATION FOR PROFESSIONS REGULATED BY THE STATE
- BACKGROUND CHECKS FOR ADOPTION, FOSTER CARE, OR VOLUNTEER WORK
- LAW ENFORCEMENT INVESTIGATIONS AND PROSECUTIONS
- PERSONAL REVIEW OF ONE'S OWN CRIMINAL RECORD

RESTRICTIONS AND COMPLIANCE

EMPLOYERS AND OTHER ENTITIES MUST COMPLY WITH THE FAIR CREDIT REPORTING ACT (FCRA) AND TEXAS STATE LAWS WHEN USING CRIMINAL HISTORY REPORTS. THIS INCLUDES OBTAINING WRITTEN CONSENT BEFORE PERFORMING BACKGROUND CHECKS, PROVIDING ADVERSE ACTION NOTICES IF EMPLOYMENT IS DENIED BASED ON THE REPORT, AND ENSURING ACCURACY AND CONFIDENTIALITY OF THE INFORMATION. UNAUTHORIZED USE OR DISCLOSURE OF CRIMINAL HISTORY INFORMATION CAN RESULT IN LEGAL PENALTIES.

STATE VS. FEDERAL CRIMINAL RECORDS

UNDERSTANDING THE DISTINCTION BETWEEN STATE AND FEDERAL CRIMINAL RECORDS IS ESSENTIAL WHEN OBTAINING A CRIMINAL HISTORY REPORT TEXAS. EACH TYPE OF RECORD IS MAINTAINED BY DIFFERENT AGENCIES AND COVERS DIFFERENT TYPES OF OFFENSES.

STATE CRIMINAL RECORDS

STATE CRIMINAL RECORDS IN TEXAS ARE MAINTAINED PRIMARILY BY THE TEXAS DEPARTMENT OF PUBLIC SAFETY AND INCLUDE OFFENSES COMMITTED UNDER TEXAS STATE LAW. THESE RECORDS COVER MOST CRIMINAL ACTIVITIES SUCH AS THEFT,

ASSAULT, DRUG OFFENSES, AND TRAFFIC VIOLATIONS HANDLED AT THE STATE AND LOCAL LEVELS.

FEDERAL CRIMINAL RECORDS

FEDERAL CRIMINAL RECORDS INVOLVE VIOLATIONS OF FEDERAL LAW AND ARE MAINTAINED BY FEDERAL AGENCIES SUCH AS THE FEDERAL BUREAU OF INVESTIGATION (FBI). THESE RECORDS INCLUDE OFFENSES LIKE FEDERAL DRUG TRAFFICKING, IMMIGRATION VIOLATIONS, AND WHITE-COLLAR CRIMES. ERRORS IN CRIMINAL HISTORY REPORTS TEXAS CAN OCCUR DUE TO MISTAKEN IDENTITY, OUTDATED INFORMATION, OR CLERICAL MISTAKES. IT IS CRUCIAL TO ADDRESS THESE INACCURACIES PROMPTLY TO PREVENT ADVERSE CONSEQUENCES IN EMPLOYMENT, LEGAL MATTERS, OR PERSONAL REPUTATION.

STEPS TO CORRECT ERRORS

INDIVIDUALS WHO IDENTIFY ERRORS IN THEIR CRIMINAL HISTORY REPORT SHOULD FOLLOW THESE STEPS:

1. OBTAIN A COPY OF THE REPORT TO REVIEW ALL DETAILS CAREFULLY.
2. CONTACT THE TEXAS DEPARTMENT OF PUBLIC SAFETY OR THE REPORTING AGENCY TO FILE A DISPUTE.
3. PROVIDE SUPPORTING DOCUMENTATION SUCH AS COURT ORDERS, IDENTIFICATION, OR AFFIDAVITS.
4. REQUEST AN OFFICIAL CORRECTION OR UPDATE TO THE RECORDS.
5. FOLLOW UP TO ENSURE THE CHANGES HAVE BEEN IMPLEMENTED.

TIMELY CORRECTION OF ERRORS HELPS MAINTAIN AN ACCURATE CRIMINAL RECORD AND PROTECTS INDIVIDUALS FROM UNJUST TREATMENT BASED ON INCORRECT INFORMATION.

FREQUENTLY ASKED QUESTIONS

HOW CAN I OBTAIN A CRIMINAL HISTORY REPORT IN TEXAS?

YOU CAN OBTAIN A CRIMINAL HISTORY REPORT IN TEXAS BY SUBMITTING A REQUEST THROUGH THE TEXAS DEPARTMENT OF PUBLIC SAFETY (DPS) CRIME RECORDS SERVICE EITHER ONLINE, BY MAIL, OR IN PERSON. YOU WILL NEED TO PROVIDE YOUR FINGERPRINTS AND PAY A PROCESSING FEE.

WHAT INFORMATION IS INCLUDED IN A TEXAS CRIMINAL HISTORY REPORT?

A TEXAS CRIMINAL HISTORY REPORT TYPICALLY INCLUDES AN INDIVIDUAL'S ARRESTS, CHARGES, CONVICTIONS, SENTENCING INFORMATION, AND SOMETIMES INCARCERATION RECORDS WITHIN THE STATE OF TEXAS.

CAN EMPLOYERS ACCESS MY CRIMINAL HISTORY REPORT IN TEXAS?

YES, EMPLOYERS IN TEXAS CAN ACCESS YOUR CRIMINAL HISTORY REPORT BUT USUALLY ONLY WITH YOUR WRITTEN CONSENT,

ESPECIALLY FOR POSITIONS THAT REQUIRE BACKGROUND CHECKS OR ARE REGULATED BY LAW.

HOW LONG DOES IT TAKE TO GET A CRIMINAL HISTORY REPORT IN TEXAS?

THE PROCESSING TIME FOR A CRIMINAL HISTORY REPORT IN TEXAS CAN VARY BUT GENERALLY TAKES BETWEEN 7 TO 14 BUSINESS DAYS IF REQUESTED BY MAIL. ONLINE REQUESTS MAY BE PROCESSED FASTER.

ARE JUVENILE RECORDS INCLUDED IN THE TEXAS CRIMINAL HISTORY REPORT?

JUVENILE RECORDS ARE GENERALLY CONFIDENTIAL IN TEXAS AND ARE NOT INCLUDED IN ADULT CRIMINAL HISTORY REPORTS UNLESS THE INDIVIDUAL WAS CHARGED AS AN ADULT OR THE COURT ORDERS OTHERWISE.
