THIS APPROACH NOT ONLY ENHANCES THE UNDERSTANDING OF INDIVIDUAL TEXTS BUT ALSO CONTRIBUTES TO THE BROADER DISCOURSE ON RACE, EQUITY, AND REPRESENTATION IN CULTURE.

DEFINITION AND SCOPE
