

DIFFERENTIAL EQUATIONS DYNAMICAL SYSTEMS AND AN INTRODUCTION TO CHAOS SOLUTIONS CHAPTER 1

1.2 IMPORTANCE OF DIFFERENTIAL EQUATIONS
